CURRENT STATE OF THE PRESCRIPTION DRUG MONITORING PROGRAM



PDMP PROCESS

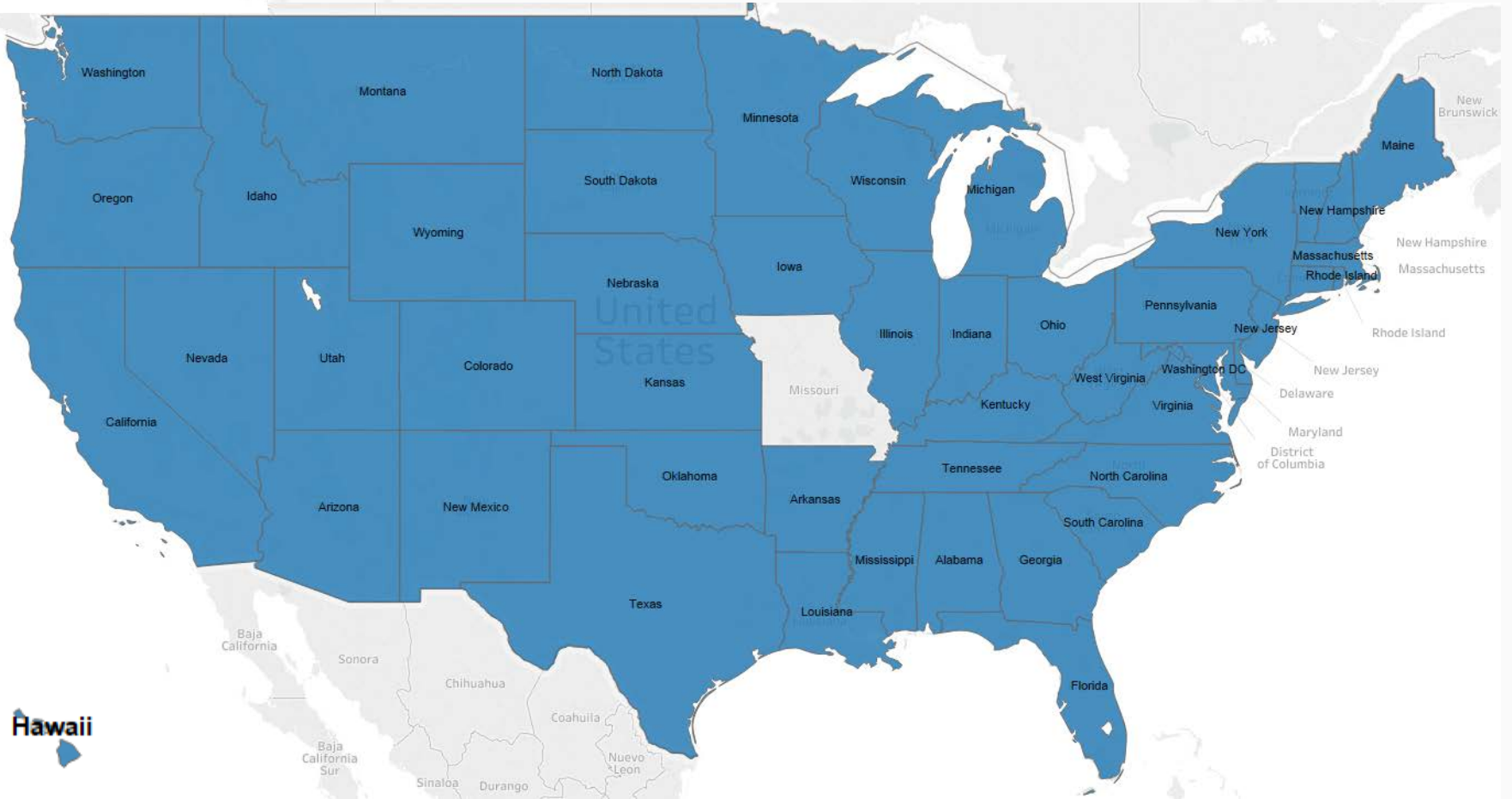
1. Pharmacies and other dispensers of monitored prescription drugs collect and submit data to the PDMP.
2. The data is added to a statewide database.
3. Authorized users may obtain PDMP data to verify prescription information.

SIGNIFICANT LEGISLATIVE CHANGES

- **Biennial Budget**
 - 2015 WI Act 55
- **HOPE Agenda Legislation**
 - 2013 WI Act 199
 - 2015 WI Act 266
 - 2015 WI Act 267
 - 2015 WI Act 268



2015 ACT 55

- Transfers PDMP oversight from the Pharmacy Examining Board to the Controlled Substances Board
- Adds members to the CSB:
 - Medical Examining Board Chair
 - Dental Examining Board Chair
 - Board of Nursing Chair



2015 ACT 55

- Requires CSB to review and disclose PDMP data to state agencies and law enforcement when the CSB identifies **“critically dangerous conduct or practices of a pharmacy, pharmacist, practitioner, or patient”**
- Effective Date: July 13, 2015



H.O.P.E. AGENDA LEGISLATION

2013 Act 199:

- Requires individuals to be known to the dispenser or show proper identification when picking up schedule II or III opioid prescription medication and requires collected information to be submitted to the PDMP
- Effective Date of Rules: April 8, 2017



H.O.P.E. AGENDA LEGISLATION

- 2015 Act 266 changes the operation of the PDMP (Effective Date: April 1, 2017):
 - Increase data submission frequency from 7 days to 1-business day
 - Require prescribers to review PDMP data prior to issuing a prescription order for a controlled substance (some exceptions)



EXCEPTIONS TO THE REQUIREMENT TO REVIEW

1. The patient is receiving hospice care
2. The prescription order is for 3 days or less and is not subject to refill
3. The drug is lawfully administered to the patient
4. It is an emergency situation
5. The PDMP system is down or other tech failure



H.O.P.E. AGENDA LEGISLATION

- 2015 Act 266 changes the operation of the PDMP (Effective Date: April 1, 2017):
 - Allow law enforcement agencies and prosecutorial units to request PDMP data without court orders



2015 WI ACT 266 CHANGES

New standard:

- Engaged in an active and specific investigation or prosecution or monitoring patient as part of a drug court
- Data sought is reasonably related



H.O.P.E. AGENDA LEGISLATION

- 2015 Act 266 changes the operation of the PDMP (Effective Date: April 1, 2017):
 - Add access for non-prescriber healthcare and substance abuse professionals



NEW ROLES WITH ACCESS

2016 Act 266 creates these new roles:

- Medical Directors
- Registered Nurses
- Substance Abuse Counselors
- Individuals licensed and certified to treat alcohol and drug abuse



H.O.P.E. AGENDA LEGISLATION

- 2015 Act 267 creates reporting requirements for the CSB to determine the effectiveness of the PDMP and to compare actual outcomes with projected outcomes
- Effective Date: March 18, 2016



H.O.P.E. AGENDA LEGISLATION

- 2015 Act 268 requires two things:
 1. Law enforcement agencies shall report to the PDMP information about specific events
 2. The PDMP shall disseminate the information from law enforcement agencies to relevant PDMP users

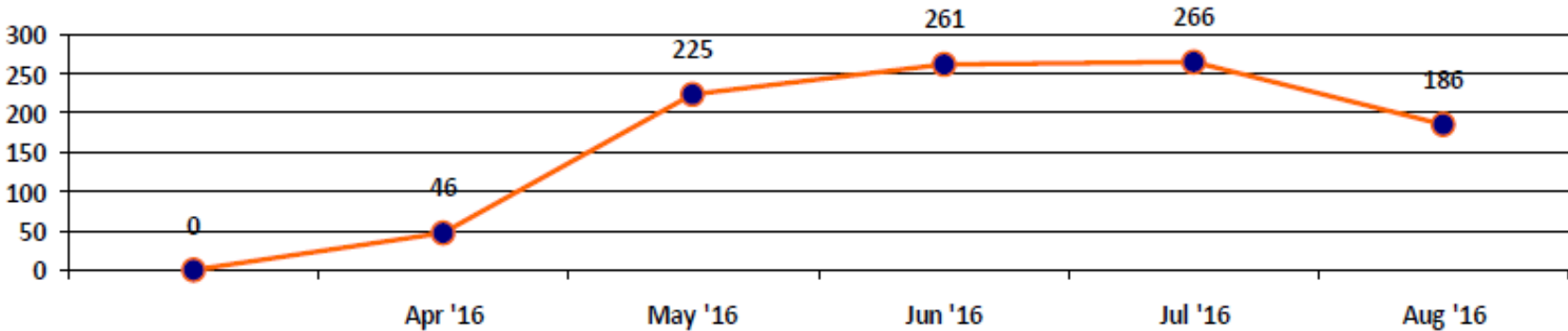


H.O.P.E. AGENDA LEGISLATION

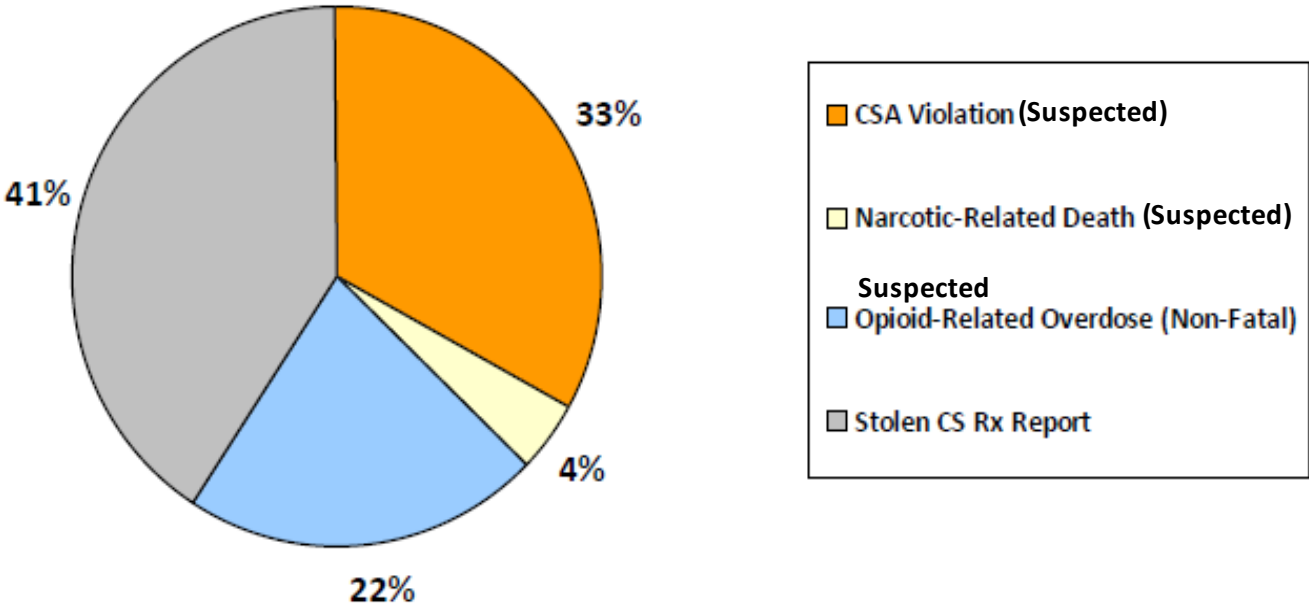
The four events identified in 2015 Act 268:

1. A suspected violation of the CSA involving a prescription drug
2. A person who is undergoing or who prior experienced an opioid-related overdose event
3. A person who may have died as a result of using a narcotic drug
4. A report of a stolen controlled substance prescription

PROJECT GOALS

The primary goals of the project are to develop the Wisconsin Enhanced Prescription Drug Monitoring Program (ePDMP) to maximize the Program's:

1. Value-added clinical workflow integrations
2. Data quality capabilities
3. Public health and public safety uses



PROJECT TIMELINE

- 2013 – 2015: Discovery and Scoping
- November 2015: Statement of Work for ePDMP development approved
- January 2016: Development Sprints began
- **Q4 2016: ePDMP Go Live**
