


Nalox-Zone Program




ED2Recovery+

- Intervention at the time of an overdose or other incident by the peer support provider in the ED setting is crucial. Nationally, there is data suggesting that approx 80% of individuals who receive peer support in an ED setting after experiencing an overdose will seek some type of recovery support service.
- We can provide peer support to anyone affected by opioid use
 - 3 Tiers:
 - Hospital/ED
 - Those at high risk of an overdose
 - Those affected by an opioid use disorder




ED2Recovery+ locations & Partnerships
