The Drug Abuse Treatment Act of 2000 (DATA 2000) specifies training necessary for prescribers to obtain a waiver to engage in office-based treatment of opioid use disorders with buprenorphine. This course addresses those requirements using a curriculum approved by CSAT/SAMHSA and ASAM, the organizations named in the DATA 2000 legislation as eligible to prepare and administer these courses.

His research focuses on the treatment and prevention of substance use disorders and related complications in settings outside of the specialist treatment settings.

She spent 20+ years in general internal medicine practice in Madison, specializing in complex medical management of geriatric patients. Her clinical interests include increasing recognition and treatment of substance use disorders within the primary care setting and expanding education on SUDs for medical trainees and medical teams, in order to promote improved care for patients with SUDs as they interact with the medical system.

The ASAM Treatment of Opioid Use Disorder Course covers all evidence-based practices and medications for treating patients with opioid use disorder.

The ASAM Treatment of Opioid Use Disorder Course is designed for:

- Physicians, nurse practitioners, physician assistants, and healthcare team members working with patients with opioid use disorder.
- Physicians, nurse practitioners, and physician assistants who wish to obtain a waiver to prescribe buprenorphine in office-based treatment of opioid use disorder.

Course Format:

- Blended – four hours online, four hours live webinar
 - Four hours of self-paced online learning to be completed **before** September 30th, 2021, or within 30 days after course date.
 - Four hours of live (webinar) learning on September 30th, 2021 from Madison, WI

This combined training of four hours live/four hours online satisfies eight hours of education requirements for providers to qualify for a DEA DATA 2000 waiver. Upon completion of this 8-hour course, physicians qualify for the waiver to prescribe buprenorphine in an office-based setting. **NPs and PAs can qualify after completing an additional 16 hours provided by ASAM**, the American Association of Nurse Practitioners, and the American Academy of PAs, for no charge.
