THE DFM AT A GLANCE

The vision of the UW Department of Family Medicine (DFM) is to improve the health of the people of Wisconsin and the nation through leadership in family medicine education, clinical practice, research and community service.

KEY FACTS

- Chair: **Valerie Gilchrist, MD**
- Administrative offices located at Alumni Hall in Madison. Education, research and patient care takes place statewide.
- FY14 revenue: \$104 million
- Ranked seventh of family medicine departments nationwide in *US News & World Report's* 2015 edition.
- Residency program created in 1970 as one of the original 15 family practice residency programs; approved as a department in 1973.

OUR PEOPLE

- 864 employees (including 173 faculty) plus affiliations statewide.
- 4 new faculty in FY14; 4 faculty promotions.

EDUCATION

- Medical student education includes required and elective coursework, clerkships, workshops and summer experiences.
- Statewide residency programs (DFM-managed and affiliated) are dually accredited by ACGME and AOA and educated 123 residents in 2014. Of the 40 who graduated in 2014, 25 (63%) entered practice in Wisconsin.
- Academic, addiction medicine, integrative medicine, sports medicine, complementary and alternative medicine (CAM) and primary care research fellowships offered.
- Campus- and community-based MPAS program educated 84 students; 36 graduated in 2014. Of clinically employed graduates, 24 (69%) entered practice in Wisconsin and 11 (31%) entered primary care. Also, 19 students were enrolled in the master's completion program.

PATIENT CARE

- 404,071 patient visits at 21 statewide clinics, and 27,577 patient visits at three urgent care sites.

RESEARCH

- \$7.8 million in grant awards in FY14. Research interests include alcohol/ substance abuse, complementary/integrative medicine and nutrition/obesity prevention.
- Wisconsin Research and Education Network (WREN) partnered with primary care clinicians and communities.

January >> Resident **Konstantin Mikeyhev, DO**, and graduate **Aaron Dunn, MD**, received awards at the WAFP's annual meeting.

March >> *US News & World Report* ranked the DFM seventh among family medicine departments in its 2015 edition.

April >> **Rachel Grob, MA, PhD**, a national expert on qualitative research, joined the DFM.

May >> The DFM received the AAFP's "Top Ten" award for matching medical students into family medicine.

The DFM honored 27 medical students, residents, and faculty mentors at the McGovern-Tracy Scholars Award ceremony.

June >> 40 residents graduated; 25 (63%) entered practice in Wisconsin.

WELCOME FROM THE CHAIR



Welcome to the DFM's FY14 Annual Report, a summary of our activities from July 1, 2013, through June 30, 2014.

In FY14, we provided outstanding care for 404,071 patient visits in 21 statewide clinics—including the new UW Health Arboretum Family Medicine Clinic—and over 27,577 patients at three urgent care sites.

Our clinical teams also improved the quality and delivery of patient care through extensive participation in the UW Health primary care redesign initiative. All of our clinics implemented the first phase of the Care Model redesign, while providing patients with a positive experience at every encounter, and we're preparing to launch the second phase in FY15.

We continued to uphold our commitment to educating much-needed primary care providers for Wisconsin. Of the 40 residents and 35 physician assistants who graduated in FY14, 63 percent and 68 percent, respectively, entered practice in-state. We also supported the teaching of 580 UW School of Medicine and Public Health (SMPH) students, and on Match Day, 15 percent of SMPH graduates chose family medicine residencies—nearly double the national average of 8.5 percent. In May, the American Academy of Family Physicians (AAFP) awarded us their “Top Ten” award for being among the best in the nation for matching students into family medicine.

In FY14, residents in our Wausau residency program became Aspirus employees; the DFM remains the program's institutional sponsor. We continue to collaborate with our Fox Valley program as it changes its structure from a DFM-administered program to a new organization developed in collaboration with ThedaCare, Ministry Health Care, and the Medical College of Wisconsin.

On the research front, we proudly welcomed Rachel Grob, MA, PhD, a national expert in qualitative, patient-centered research, as a senior scientist in the DFM. Dr. Grob's appointment is shared with the UW Center for Patient Partnerships (CPP), and represents the first formal partnership between an SMPH department and the CPP.

We also paid tribute to two cherished faculty members we lost last year: Gene Farley, MD, MPH, and Jeff Patterson, DO (see tribute on page 4). Both were outstanding physicians and incredible people, and we miss them greatly.

Finally, we furthered progress toward becoming a department of family medicine and community health through curricular enhancements, clinic-based healthy living initiatives, and local partnerships. These efforts, together with our sustained focus on accountability and integration, will allow us to improve the lives of our patients, families, and communities for long into the future. Because health lives here, in Wisconsin.

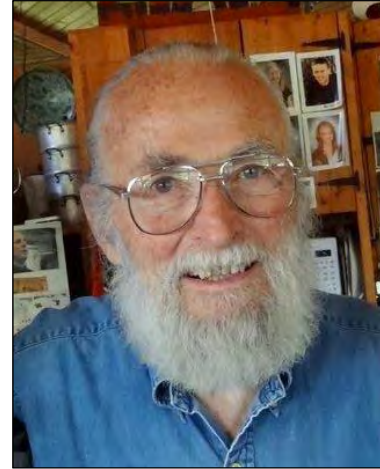
IN MEMORIAM

Gene Farley, MD, MPH: 1927–2013

Gene Farley, MD, MPH, a “father of family medicine,” a former DFM chair and a mentor and friend to many, died on November 8, 2013.

Dr. Farley’s career began in the 1950s, before family medicine was a formal discipline. He and his wife Linda ran a clinic on a Navajo reservation and then had a practice in rural upstate New York. In 1967, he developed one of the first family medicine residency programs at the University of Rochester. He came to Wisconsin in 1982 to serve as DFM chair.

For many years, the Farleys advocated for national health care and trained many clinicians to work in underserved communities. In 2009, Dr. Farley created the Linda and Gene Farley Center for Peace, Justice and Sustainability in Verona, Wisconsin.

Jeff Patterson, DO: 1946–2014

Jeffrey Patterson, DO, a professor emeritus at the DFM, and a health and environmental activist, died unexpectedly on January 23, 2014.

Dr. Patterson joined the DFM as a resident in 1973. He cared for patients at the Northeast Family Medical Center for nearly 40 years, and was its medical director from 1989 to 1991. He was also a world-renowned expert in prolotherapy, publishing many papers on the procedure and directing an annual international prolotherapy conference in Madison.

Dr. Patterson was deeply involved with Physicians for Social Responsibility (PSR), a member of International Physicians for the Prevention of Nuclear War and the medical director of the Hackett Hemwall Foundation.

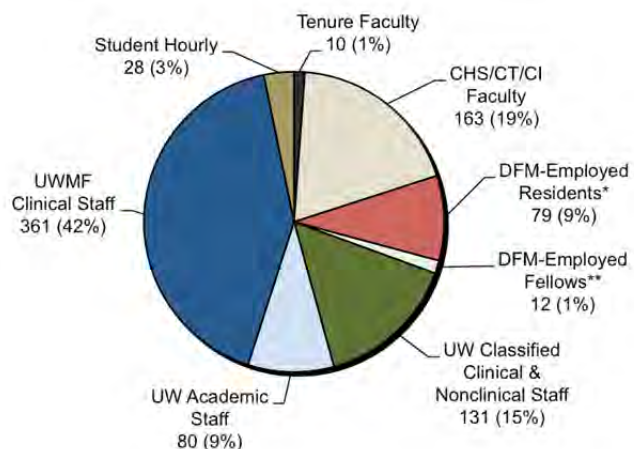

Promoted to Associate Professor

Dr. Brown joined the DFM in 2001 as a clinical instructor. Based in Madison, he is the director of the UW Hospital and Clinics' Center for Addictive Disorders, the founding director of the DFM's addiction medicine fellowship, the director of the UW School of Medicine and Public Health's (SMPH) fourth-year clinical addiction elective, and the medical director of the AIDS Resource Center of Wisconsin's Overdose Prevention Program. His primary interests are the treatment and prevention of substance use disorders and their complications, particularly among people in the criminal justice system.

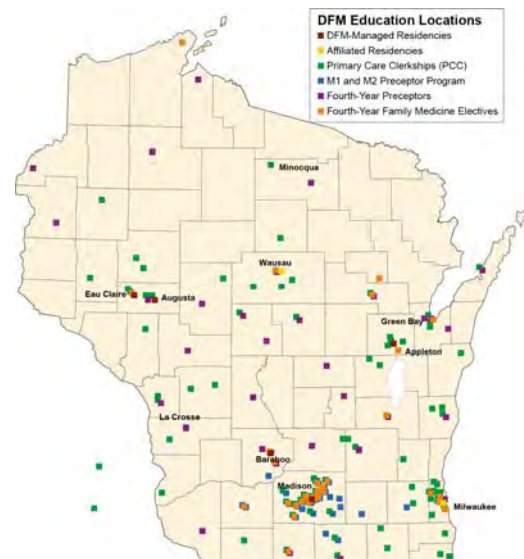

From coursework to special programs to hands-on mentoring, the DFM's Office of Medical Student Education supports students through all four years of their education at the UW School of Medicine and Public Health (SMPH).

We are grateful for the efforts of our dedicated family medicine faculty and staff, and especially our statewide network of volunteer community-based teachers (listed in Section 7, "Clinical Adjunct Faculty").

Together, we help medical students discover the principles and possibilities of family medicine.

2.1.1. GENERAL HIGHLIGHTS

Last year, the Office of Medical Student Education:

- Opened HEART-IM as a new fourth-year elective and filled to capacity its first year.
- Received (jointly with Wisconsin AHEC) the third of a three-year, \$74,000 Reilly Baldwin Wisconsin Idea grant to promote development of community teaching partners;
- Successfully opened new PCC sites in Lake Geneva, Merrill/Mosinee, Colby/Stratford, Viroqua and Sparta;
- Funded 24 medical students' attendance at the 2013 American Academy of Family Physicians' National Conference of Family Medicine Residents and Medical Students in Kansas City;
- Welcomed 41 students at the 12th annual Essen Haus event, a recruiting partnership between the Wisconsin Academy of Family Physicians (WAFP) and the Family Medicine Interest Group (FMIG), on February 3, 2014;
- Trained 138 students at its annual procedures fair on March 12, 2014;
- Hosted 20 preceptors and staff at the PCC Faculty Development and Appreciation Dinner on May 1, 2014, and awarded the first PCC Preceptor Awards for excellence in teaching medical students; and
- Supported 10 student posters created from Primary Care Clerkship (PCC) community engagement projects for the SMPH's annual Medical Education Day on May 2, 2014.

Thanks to generous scholarships from the AAFP, WAFP and DFM, 24 SMPH students were able to attend the 2013 AAFP National Conference in Kansas City.

2.1.2. PROGRAM-SPECIFIC HIGHLIGHTS

Patient, Doctor, and Society (PDS)

PDS is the core clinical course in the first two years of medical school. It teaches history taking and physical examination skills, plus topics like professionalism, health disparities and health systems.

In FY14, 27 DFM faculty and residents led 64 medical students in the course's weekly "small group" learning sessions.

M1 and M2 Preceptor Program (family medicine section directed by David Deci, MD)

The M1 and M2 Preceptor Program introduces first- and second-year medical students to clinical medicine by pairing them with primary care physicians from around Wisconsin.

In FY14, the program paired 204 medical students with 141 statewide preceptors.

Primary Care Clerkship (PCC) (directed by Mark Beamsley, MD)

Using a statewide network of community preceptors, the PCC gives third-year medical students in-depth experience assessing and managing patients in the outpatient setting.

In FY14, the PCC matched 161 medical students with 156 family medicine preceptors statewide.

Fourth-Year Preceptorship (directed by Paul Hunter, MD)

This experience gives fourth-year medical students insight into the relationships between clinical care, public health and the health of the community.

In FY14, 72 medical students worked with 39 family medicine preceptors statewide.

Fourth-Year Family Medicine Electives (directed by David Deci, MD)

Electives give students additional experiences in inpatient medicine, integrative medicine, rural medicine and care of underserved communities.

In FY14, 79 medical students participated in 119 family medicine electives with 135 family medicine preceptors statewide.

Nationally recognized for its educational excellence, the DFM prepares residents to practice full-spectrum family medicine, with particular attention to health promotion within their communities.

In FY14, 123 residents trained at the following residency programs:

- 6 at Baraboo Rural Training Track (6 MD);
- 14 at Eau Claire and the alternative training site in Augusta (12 MD, 2 DO);
- 18 at Fox Valley (Appleton) (13 MD, 5 DO);
- 41 at Madison's four clinical training sites: Belleville, Northeast, Verona and Wingra (36 MD, 5 DO);
- 28 at Milwaukee (17 MD, 11 DO); and
- 16 at Wausau (11 MD, 5 DO).



Each residency program has full accreditation status, and is dually accredited by the Accreditation Council for Graduate Medical Education (ACGME) and the American Osteopathic Association (AOA). Residents in our statewide osteopathic program train at each of the above sites.

2.2.1. STATEWIDE HIGHLIGHTS

New Residents

In academic year 2013-2014, 44 residents entered our statewide programs:

- 2 in Baraboo;
- 5 in Eau Claire/Augusta;
- 6 in Fox Valley;
- 14 in Madison;
- 10 in Milwaukee; and
- 7 in Wausau.

Graduates and Practice Plans

In academic year 2013-2014, 40 residents graduated from our programs:

- 2 from Baraboo;
- 4 from Eau Claire/Augusta (including one who will graduate in February 2015);
- 6 from Fox Valley;
- 14 from Madison;
- 9 in Milwaukee; and
- 5 from Wausau.

Of these 40 graduates:

- 25 (63%) remained in Wisconsin:
 - 20 (50%) entered in-state practice
 - 5 (13%) entered in-state residencies or fellowships (1 preventive medicine residency, 1 geriatrics fellowship, 1 primary care research fellowships, 1 academic fellowship and 1 integrative medicine fellowship)
- 13 (32%) will practice outside of Wisconsin:
 - 12 (30%) entered out-of-state practice
 - 1 (2%) entered an out-of-state fellowship (in sports medicine)
- 2 (5%) were yet to be determined at the time of publication.

Initiatives

- **Next Accreditation System transition.** All residency programs transitioned to ACGME's Next Accreditation System (NAS), which provides continuous (versus episodic) monitoring of programs and sponsoring institutions.
- **Milestones implementation.** All residency programs began preparing to implement the family medicine milestones, a framework for determining resident performance within the six ACGME Core Competencies (Patient Care, Medical Knowledge, Professionalism, Interpersonal and Communication Skills, Systems-Based Practice, and Practice-Based Learning and Improvement). Programs also shared evaluation strategies and tools at a Milestones workshop in May 2014.
- **Behavioral health curriculum.** In response to survey feedback, the department is developing a standard observation tool for a behavioral health curriculum, and the faculty leader for statewide behavioral health is working with programs to meet curricular needs and create shared resources.

WRPRAP EXTENDS REACH, FUNDS DIVERSE RURAL GME OPPORTUNITIES

The Wisconsin Rural Physician Residency Assistance Program (WRPRAP) is in its fourth year as a DFM-administered program designed to leverage state funding to expand resident education opportunities in rural community settings.

In each succeeding year, WRPRAP has extended its reach and diversified its grantee pool. In FY14, it awarded \$765,279 among 10 programs in all of the grant categories that WRPRAP awards. Ranging from \$11,000 to \$150,000 and spanning efforts from supporting rural rotations to initiating new Rural Training Tracks (RTTs), WRPRAP support stimulated interest, initiative and collaboration toward preparing the much-needed medical workforce rural Wisconsin requires. More specifically, WRPRAP funded:

- Five early development grants across the state, across eligible specialties and across a range of purposes supporting:
 - feasibility studies exploring options for assessing viable GME programming (Ashland Medical Center; Bellin Memorial Hospital, Oconto/Oconto Falls);
 - development steps in initiating a new community-based RTT (Aurora Health Care, Milwaukee);
 - training for program director of a new family medicine program (Gundersen Medical Foundation, La Crosse);
- An education development grant supporting rural pediatrics rotations (UW SMPH, Madison)
- Three major grants supporting:
 - development of a new rural training track within a general surgery residency (UW SMPH, Madison)
 - development of hospitalist and emergency department fellowships (Monroe Clinic)
 - continuing development of a statewide consortia for supporting rural GME via outreach, training and technical assistance (Wisconsin Collaborative for Rural Graduate Medical Education, Sauk City)

In addition to grant awards, WRPRAP has played a leadership role in rural GME development through participation in state and national rural groups, and through actively encouraging collaboration among health systems, academic institutions and community leaders.

The DFM's statewide osteopathic program operates at each residency site. Residents simultaneously complete osteopathic certification requirements while participating in their site's allopathic curriculum.

Education Highlights

- **OMT workshop curriculum.** Each year, the program conducts four hands-on osteopathic manipulative therapy (OMT) workshops for osteopathic residents.

This year, the program moved to a problem-based curriculum, using data from the programs' top diagnoses seen in clinics to guide the topics. In addition, residents do a case presentation on the workshop topic, and faculty present on a practice management topic.

- **Recruitment.** The program matched a record number of first year residents in 2014, with an incoming class of 17 residents. The American Osteopathic Association approved an increase to our total resident slots to 40 statewide.

The Baraboo RTT is committed to preparing physicians for rural practice. It is the only program of its kind in Wisconsin, and one of only a few in the country.

Education Highlights

- **Educating residents for rural practice.** Since the Baraboo RTT opened in 1996, 78% of graduates are in rural family medicine practice, 76% provide maternity care in rural communities, 50% have stayed in Wisconsin, and five are on the Baraboo RTT faculty—important outcomes as rural physician shortages loom and rural hospitals close their obstetrics units.
- **Rural residency training initiatives.** **Stuart Hannah, MD**, and Angela Womble continue to serve on the Wisconsin Collaborative for Rural Graduate Medical Education (WCRGME). Dr. Hannah is also a rural family medicine residency consultant for several rural Wisconsin hospitals and RTTs around the nation.

The Eau Claire/Augusta residency teaches community-connected care in a state-of-the-art facility. Through a strong collaboration with Chippewa Valley Technical College, resources include a human simulation lab and virtual hospital.

Education Highlights

- Pediatric emergency rotation.** PGY-3 residents completed two-week rotations at Children's Hospitals and Clinics of Minnesota during the 2013-2014 year. This rotation was added to the requirements in anticipation of ACGME requirements implemented in July of 2014 requiring pediatric emergency numbers.
- Pre-residency curriculum.** In May and June 2014, four incoming residents took advantage of our externship program, which provide structured experiences for international medical graduates to increase their understanding of the basic skills needed, and gain greater exposure to the U.S. health care system.
- Curriculum reviews.** The faculty curriculum coordinator and the education coordinator have continued to review and revise each curriculum with a goal of every-other-year reviews. The program director, faculty curriculum coordinator and/or the education coordinator meet with physician rotation coordinators as needed to more make changes to curriculum to accurately reflect expectations and what the rotation provides. Suggested curriculum revisions are presented at faculty meetings and education committee meetings.
- Obstetrics rotation changes.** OB rotations have been reduced to four for the class of 2017.

The Fox Valley residency program is well integrated into the community, receiving tremendous support for its educational program, clinical training center, residents and graduates.

Education Highlights

- **Pediatric service.** After reviewing historical hospital admission data, the Fox Valley program changed its pediatrics service to run from November through April—the highest-volume months for pediatric patients.
- **Grants.** The Fox Valley program was awarded three grants in the 2013-2014 academic year to help realize the goals of increasing the number of primary doctors in the state of Wisconsin and increasing exposure to rural medicine. They include a Department of Health Services grant to increase the intern class from 6 to 7 residents for the next the years, a Wisconsin Rural Physician Residency Assistance Program (WRPRAP) rural rotation grant to support new rural rotations, and a WRPRAP education development grant to allow residents on rural rotations video access to didactics that routinely occur at the residency.

The Madison residency program offers a robust curriculum nurtured by a supportive community of residents, faculty and staff. Residents care for a dedicated patient panel for three years at one of four continuity clinics.

Education Highlights

- **Formative Feedback Resident Education (FFREd).** The program implemented Formative Feedback Resident Education (FFREd), an OSCE-like assessment to evaluate incoming residents as part of the initial milestone evaluation. Residents were given a patient scenario, interviewed the standardized patient, consulted with faculty, and returned to the patient with a care plan.
- **TEACH cards.** The program implemented TEACH (Teaching EBM and Clinic Topics in the Hospital) cards on the St. Mary's family medicine service. The cards cover 25 core topics in adult inpatient medicine and include prompts for teaching/discussion about basic concepts and common management decisions, as well as a primer on evidence-based medicine (EBM).
- **New EKG curriculum.** The program added a longitudinal EKG curriculum to the first-year seminar series. In it, a first-year resident prepares an EKG and presents it to his/her peers, who collaborate using established guidelines to read the EKG together.

- The clinic redesigned schedules to allow a 15-minute rooming time throughout the day. In addition, in response to patient requests, the clinic started lab appointments 30 minutes earlier each morning.
- The clinic launched "Belleville Walk with a Doc," a community outreach project to promote walking as part of a healthy lifestyle. A Belleville clinician presented a weekly 5-minute talk on various subjects, and walked the Lake Bellevue path with all attendees.
- The Belleville QI Group (Green Team) was awarded the James E. Davis Quality Improvement Award for their project "Lab Result Communication." The project designed a new way for lab results to be communicated from the physician to the patient via the RNs.

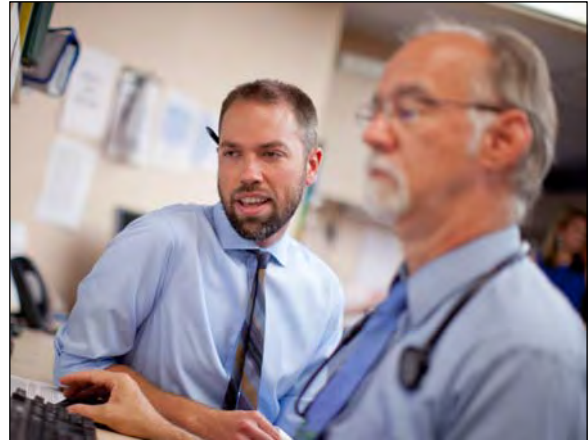

Education Highlights

- New Weston site.** The Wausau program successfully established an accredited family medicine practice for residents at Aspirus Weston Clinic. Each year, one second-year resident will move his/her clinical practice to the Weston site for the second and third years of residency. Weston physicians join the program's core faculty and will supervise and evaluate resident performance in clinic.

The University of Wisconsin Physician Assistant (PA) Program is a nationally recognized, masters-level program administratively linked with the DFM. The PA program and the DFM have complementary missions: to promote the primary care needs of Wisconsin and beyond, including rural, urban, and underserved populations.

UW-PRIME Participation

The HRSA-funded *Public Health and Primary Care Innovations in Medical Education* (UW-PRIME) is an SMPH initiative that aims to integrate public health curriculum and community engagement into PA, MD and other health care education programs.

As part of that initiative, 24 first-year and 12 second-year PA students are currently in their second year of participation in the Path of Distinction (PoD) in Public Health. Students in the PoD choose from global health, population health or rural health tracks, and complete coursework, service-learning experiences and a capstone project related to that track.

Also as part of UW-PRIME, the PA Program has finalized plans and is reviewing applications for a new PA/MPH dual-degree program, which will begin in the fall of 2015.

First wisPACT Students

In May 2014, the first four PA students entered the Wisconsin Physician Assistant Community-based Track, or *wisPACT*. A collaboration between UW-Madison, UW-Marathon County and health systems in northern Wisconsin, *wisPACT* aims to provide PA education in northern and north-central Wisconsin, and graduate more PAs who plan to work in areas where there is a shortage of primary care physicians.

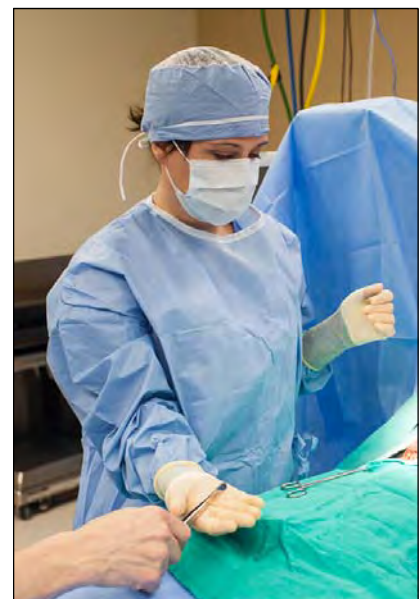

Simulation Training

One of the best ways to teach students to apply medical knowledge to a “real” situation is to place them in a challenging environment that simulates an actual patient. In addition to routinely using standardized patients, the PA Program uses the UW Health Clinical Simulation Program in its surgery class, teaching scrubbing, gowning, gloving, and prepping and draping a patient in a full-size OR.

Building on this success, the program has since built on this success, and last year, finalized plans to use the Simulation Program to teach an emergency medicine scenario for clinical-year students.

PA PROGRAM GRADUATES RECOGNIZED FOR SCHOLARSHIP

The Capstone project is the embodiment of the graduate degree. Students study a subject for the duration of their degree program, acquiring a significant depth of knowledge on that topic.

They then share their “capstone” achievement in their second year by presenting the results of their paper to faculty and peers.

At the 2014 commencement ceremony, faculty acknowledged the following students for special achievement in completion of their Capstone paper:

Michael Conway Jr., PA: “The Effects of Professional Translation Services on Quality of Care in Emergency Departments.” Michael explored the benefit of using professionally trained interpreters in the Emergency Department compared with other forms of interpreters, such as ad hoc interpreters and telephonic services. Overall, the data points to professional interpreters as being a better option than other translation options in terms of patient satisfaction, patient understanding and errors committed.

Rebecca Flax, PA: “Increasing Cervical Cancer Screening Rates Among Latina Women: The Effectiveness of Promotoras de Salud.” Rebecca investigated whether the use of targeted, culturally sensitive interventions by lay health educators (“Promotoras de Salud”) increases cervical cancer screening rates among Latina women, and found evidence supporting their effectiveness.

Jonathan LaCore, PA: “The use of *Necator americanus* hookworm infection in asthma therapy.” Jonathan reviewed the literature to determine if hookworm infection may be used as therapeutic intervention for patients with asthma. The studies he analyzed showed no measurable difference in asthma-related symptoms between those infected and those not infected.

Elizabeth Marie Lucht, PA: “Efficacy of Peer-Delivered HIV Treatment Services in Developing Countries: A Systematic Review.” Elizabeth explored whether peer-delivered services are effective as part of the HIV/AIDS treatment team. Through her literature search, she found that peer services improved adherence in patients taking antiretroviral therapy for 96 weeks or longer, and that patients at clinical disease stages 3 and 4 experienced increased quality of life if working with a peer.

Angela Morgan, PA: “Efficacy of Infant Breastfeeding in Reducing the Prevalence of Childhood Overweight and Obesity.” Angela evaluated the efficacy of infant breastfeeding as a strategy to reduce the prevalence of overweight or obesity in school-age children 5 to 18 years of age, and found that it does play a role in lowering the prevalence of overweight or obesity in this population.

Rebecca Wachowiak, PA: “Antitrypanosomal Therapy for Chronic Chagas Cardiomyopathy.” Rebecca explored the role of antitrypanosomal therapy in preventing disease progression in patients with chronic chagas cardiomyopathy (CCC). She found that antitrypanosomals, particularly benznidazole, may be effective in certain populations to prevent progression of CCC, and that further research and results of the BENEFIT trial will help further define its role.

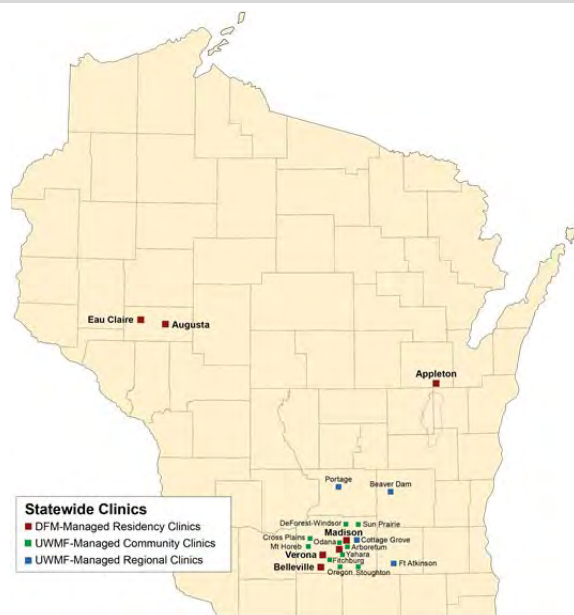

In FY14, the DFM provided 404,071 total patient visits at 21 statewide clinics.

Seven of these clinics are managed by the DFM and are residency training sites. The remaining 10 community clinics and four regional clinics are managed by the University of Wisconsin Medical Foundation (UWMF).

The DFM also provided 27,577 patient visits at three urgent care sites last year.



3.1. GENERAL HIGHLIGHTS

Primary Care Redesign

In FY14, the DFM collaborated with the University of Wisconsin Medical Foundation to improve the quality and delivery of patient care through the Primary Care Redesign (PCR) initiative.

All family medicine clinics (community and residency) fully implemented the first phase of the Care Model redesign, which focused on streamlining and standardizing the check-in and rooming processes. These workflow changes were significant and required extensive, coordinated education and training of all staff and providers. This was accomplished while providing patients with a positive experience with every “touch”—whether during a face-to-face encounter or an exchange through the electronic medical record (EMR) patient portal.

In addition, patients were encouraged to be true partners and decision makers in their own health care. Preventive screenings increased in both children and adults as a result of new EMR “Health Maintenance Alerts” and outreach initiatives.

In late spring, the DFM clinics began preparation for the second phase of PCR. This phase, which will be rolled out in FY15, has two aims: 1) optimizing the roles of MAs, RNs and providers to the top of their ability and licensure; and 2) increasing coordination of care of patients with chronic health conditions, such as diabetes and hypertension.

DFM Faculty Win UW Health Awards

In 2014, five DFM faculty—**Jennifer Edwards, MD**; **Catherine James, MD**; **Hollis King, DO, PhD**; **Jeffrey McGuire, MD**; and **Elizabeth Perry, MD**—were honored with UW Health’s third annual Patient Experience Physician Champion Awards. These physicians achieved the highest level of exemplary communication skills based on patient satisfaction surveys conducted the previous year.

At the UW Health Belleville Clinic, a Microsystems team led by **Jennifer Lochner, MD**, developed a more streamlined approach for how clinic physicians and staff communicate lab results to patients in between visits.

The team identified specific lab results that would be appropriate for an RN to communicate, and aimed to ensure that the RN communicated those results 100 percent of the time—a goal they met within four months of project launch.

Their accomplishment was recognized with the DFM's James E. Davis Award for Quality Improvement, presented at the Renner Hansen awards ceremony on November 14, 2013.

'2020 CHALLENGE' HELPS VERONA CLINIC PATIENTS LIVE HEALTHY

A DFM community health initiative at the UW Health Verona Clinic helped patients there eat better, exercise more, and live healthier lives.

The Verona Clinic 2020 Fitness and Lifestyle Challenge was aimed at clinic patients who have a body mass index (BMI) of 30 or greater.

Approximately 20 patients participated in the pilot.

A team led by the DFM's **Brian Arndt, MD**, **Maggie Larson, DO**, and **Julia Yates, MSSW**, held monthly group wellness visits, sent weekly motivational emails, and provided pedometers and suggestions for mobile apps that could support patients as they work toward their goals. The team also partnered with local businesses to offer discounts on groceries, takeout food and fitness centers.

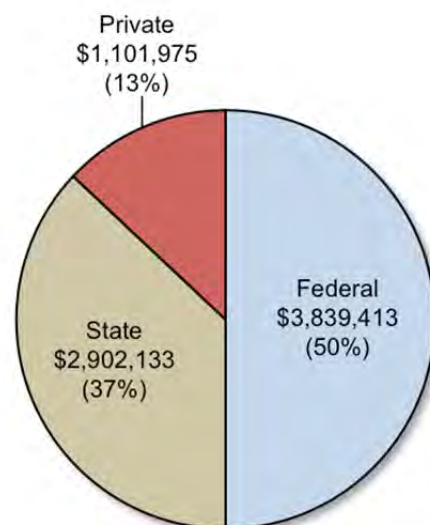

4.1. GENERAL HIGHLIGHTS

- **Grant funding.** In FY14, DFM investigators received approximately \$7.8 million in grant awards, including 27 grants from external funding sources and 12 from internal funding sources.

The DFM ranks sixth in NIH funding among departments of family medicine in U.S. medical schools.

- **Papers and presentations.** DFM investigators published 50 papers, including peer-reviewed publications, electronic publications, abstracts, books, book chapters, editorials and commentaries.

Through 55 state, national and international presentations, they also promoted the discovery and dissemination of knowledge important to teaching, clinical practice and the organization of health care.

- **Multidisciplinary collaboration for practice improvement.** The DFM is coordinating a collaboration of primary care clinicians and industrial and systems engineers that together aim to improve the practice of primary care.

This entity, the National Collaborative for Improving Primary Care Through Industrial and Systems Engineering, (I-PrACTISE), is directed by **John Beasley, MD**. It aims to help primary care clinics better direct the use of practice support systems, including electronic health record implementation and the transformation to a patient-centered medical home.

I-PrACTISE held its second national conference in Madison on March 9-11, 2014, with 69 attendees representing primary care, industrial engineering, psychology, nursing, administration, medical informatics and related disciplines.

DFM RESEARCHERS ADDRESS HEALTH CONCERNS OF VULNERABLE POPULATIONS

Last year, DFM faculty and researchers led numerous projects to address the health challenges of vulnerable populations.

Individuals in the throes of opioid addiction may resort to criminal behavior to obtain drugs and avoid acute withdrawal. Traditional adjudication and incarceration have been ineffective in breaking this pattern. Research from **Randall Brown, MD, PhD, FASAM**, evaluates collaborative service models provided to addicted offenders as alternatives to incarceration in an effort to improve individual functional outcomes as well as public safety.

John Frey, MD, and **Cindy Haq, MD**, are academic partners for the Lindsay Heights/Walnut Way Innovation and Wellness Commons, a community initiative that aims to bring educational, economic, and physical and spiritual improvement to the people of this underserved Milwaukee neighborhood.

Cindy Haq, MD, was also the academic partner on a pilot project to improve access to dental health screening, assessment and ongoing care for uninsured and low-income individuals served by the Bread of Healing Clinic in Milwaukee.

Georgiana Wilton, PhD, leads research on the prevention, identification, and treatment of prenatal alcohol exposure and fetal alcohol spectrum disorders (FASD). Last year, two projects focused on vulnerable populations: 1) Booshké giin (It's Your Decision), a CDC-funded initiative to develop universal screening and brief alcohol intervention activities within specified Tribal clinics; and 2) the Wisconsin FASD Treatment Outreach Project (WTOP), which collaborates with women's alcohol and other drug abuse treatment centers to increase knowledge about FASD and identify women at risk.

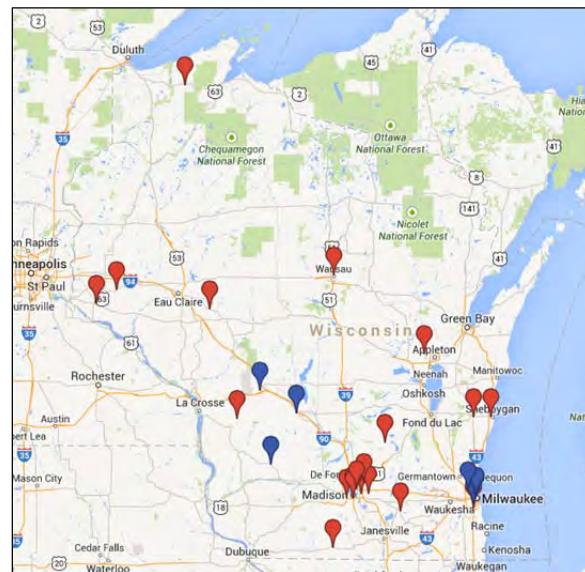

The Wisconsin Research and Education Network (WREN) is a statewide practice-based research network (PBRN) of primary care clinicians and academic researchers. Its mission is to improve health outcomes for the people of Wisconsin through education, and through promoting and conducting primary care research in partnership with clinicians and the communities they serve.

Highlights

- Sustainability.** WREN has been in continuous operation since 1987, making it one of the oldest PBRNs in the country.
- Increased funding.** WREN has continued to attract high-quality, high-caliber projects supported by federal and local funding, including private foundations.
- Engagement.** WREN now disseminates practical and research information to more than 1500 individuals, including clinicians, researchers and staff across the entire state of Wisconsin and beyond.
- Statewide research.** During FY 2014, WREN was engaged in 12 clinical and practice improvement research projects. Topics included patient safety, chronic kidney disease, cancer survivorship, influenza surveillance, vulvovaginal atrophy, clinician-patient communication, and diabetes management.

- **National Association.** WREN is a member of two AHRQ-funded Research Centers in Practice-Based Research and Learning consortiums. These consortia accelerate the generation of new knowledge and a community of learning for primary care practices to improve quality, patient safety, and effectiveness of care.
- **Patient outcomes oriented.** WREN participated in two studies that were included in a meta-analysis of the use of macrolides for the treatment of severe, uncontrolled and/or refractory asthma.

This meta-analysis found macrolides were beneficial for improving symptoms and quality of life, as well as improving peak expiratory flow and airway hyper-reactivity. 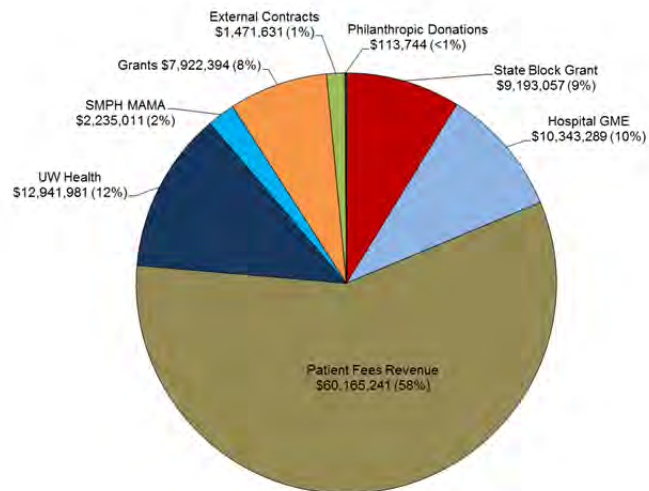

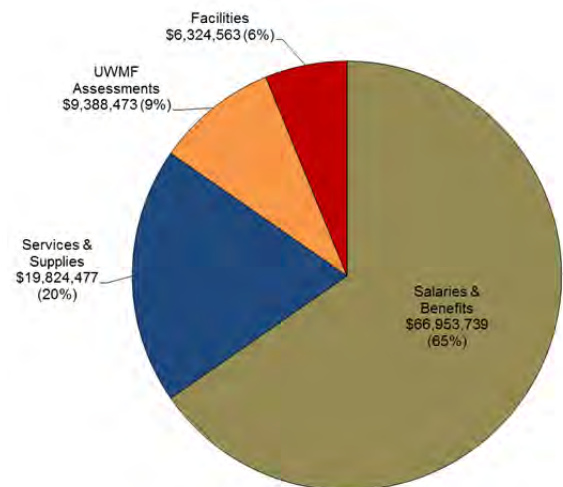
